The SEAPEX Philatelic Exhibition will have 180+ exhibition frames. In the past years, we noted more collectors attending with more interest in viewing the exhibition. This national level show is three days and we have APS-approved World Series of Philately status for the exhibits. The **American Helvetia Philatelic Society** and the **United Postal Stationery Society** will hold conventions at the show and several philatelic groups will have meetings during the show. We will host a special ceremony commemorating the theme of the show. There will be advertising in national philatelic publications and local newspapers. SEAPEX is a 501(c)(3) organization.

Please consider coming to Seattle and being a dealer at this show. The SEAPEX Committee has contracted with the Residence Inn Seattle South as our official hotel. Check out our website www.seapexshow.org for information about the show and list of dealers that have signed up.

We will provide details on unloading and set-up in a future letter. The Tukwila Community Center has free parking and easy access for unloading and loading. The room is 10,000+ square feet and is carpeted.

To assist in the preparation of the flyer sent out as part of the show advertising, please put a short note on the application informing customers about new collections, stamps, covers, and other material you will have at the show. We will include this information as part of your listing in the show program. Ads are available in the program: full-page \$50, half-page \$35, card size \$25.

We advertise this show at all the clubs in the Everett-Seattle-Tacoma-Olympia area, members of the Northwest Federation of Stamp Clubs, national publications, local press, direct mailing to APS members and our own mailing list, and on our regular show website and on Facebook.

SEAPEX is an APS-accredited NATIONAL Stamp Exhibition

This Agreement is entered into this day between **Seattle Philatelic Exhibition**, hereinafter named "SEAPEX" and _____ hereinafter named the Dealer.

In consideration of the sum of **\$300.00** (with balance due by July 13, 2018), SEAPEX agrees to provide the Dealer with an exposition space.

Both parties agree to be bound by the following terms and conditions:

1. Dealer will limit his/her business and activities to the purchase, sale, or trade of philatelic material and related supplies.
2. Dealer agrees that during the hours the exposition is open, he/she will be in attendance at the exposition space provided under the terms of this agreement, and will maintain an adequate stock of material for sale or trade. If Dealer fails to occupy the assigned exposition space upon opening of the show, he/she shall be liable for full payment of table fee.
3. Dealer is responsible for the actions of anyone working at his/her booth.
4. Dealer agrees to maintain his/her exposition space in an orderly and presentable condition.
5. SEAPEX agrees to provide security for materials in the exposition space from 7:00PM Thursday to 9:00AM Friday, from 6:00PM Friday to 9:00AM Saturday, and from 5:00PM Saturday to 9:00AM Sunday.
6. Dealer agrees not to bring any property onto the premises prior to the published move-in time and to vacate the premises, including removal of all equipment and stock in a reasonable time after the close of the show.
7. Dealer agrees that they will not bring alcoholic beverages onto the premises of any SEAPEX sponsored show.
8. Dealer agrees to hold SEAPEX, its officers, agents, and committees harmless from any liability or claim for the personal injury, property damage, or loss due to theft or other causes, and indemnify SEAPEX for any such loss or claim concerning the Dealer, his/her agents, servants, employees, associations, spectators, or customers. Dealer further agrees that SEAPEX and the TUKWILA COMMUNITY CENTER are merely providing exposition space in the show.
9. In case of cancellation, the Dealer will receive a refund of said booth deposit, provided SEAPEX is notified one month before the show. After that time, a refund will only be made if the booth can be resold.
10. Regarding the interpretation and enforcement of these rules, the decision of the SEAPEX Bourse Chairman will be final. He will also have final say on matters not included herein that may arise during the Show.
